Terms and Conditions

Welcome to Reward Spot, owned by R.L. Jordan Oil Company of N.C. Inc., doing business as Hot Spot. These Reward Spot terms and conditions form the agreement (the "agreement") between you ("you") and R.L. Jordan Oil Company and its affiliates and subsidiaries ("company"). You may contact R.L. (1) Agreement to terms. You agree to read these terms and conditions carefully before using the Reward Spot program. If you do not agree to these terms and conditions, you may not participate in the Reward Spot program. Use of the Reward Spot program signifies your agreement to the terms and conditions of use set forth below.

(2) Modification of agreement. Company reserves the right, at its sole discretion, to change, modify, add or remove any portion of this agreement, in whole or in part, at any time. Notification of changes in the agreement will be posted on www.hotspotrewardsprogram.com (the "website"). Use of the Reward Spot program after such notice will be considered your agreement to be bound by any such changes.

(3) Company's Rights in Reward Spot program. Company may change, suspend or discontinue any aspect of the Reward Spot program at any time, including but not limited to rewards and point accrual/redemption methods. Company may also impose limits on certain features and services or restrict your access to parts or all of the Reward Spot program or the website without notice or liability. Company reserves the right, in its sole discretion, to refuse service, cancel membership, suspend or terminate an account.

(4) Usage of the Reward Spot Debit. Should you use the Reward Spot debit card you agree to be debited from the checking account indicated when you enrolled and in accordance with the rules of the National Automated Clearing House (NACHA), for the amount of goods and/or services you purchase from Company. This authorization will remain in effect until company receives written notice of termination sent to the address on the back of the card or a call to the help desk is made to cancel the card using the phone number on the back of the card. You will promptly notify company if your card is lost or stolen by calling 877-648-7551, and will not change or alter your card or authorize its use by any other person. In addition, you will notify company immediately if you desire to change checking accounts using the information on the back of the card. Service charge — each returned attempted debit to your checking account is subject to maximum service charges allowed by your state of residence and may result in the suspension of Reward Spot debit card privileges until such time as the face amount of the check and/or service charges and recovery costs have been paid. There may be restrictions on the dollar amount and number of transactions that can be run. You will be notified upon enrollment of any restrictions.

(5) Indemnification for your breach of agreement. You hereby agree to indemnify, defend and hold company, and all its officers, directors, owners, agents, employees, information providers, licensors and licensees (collectively, the "indemnified parties") harmless from and against any and all liabilities and costs incurred by the indemnified parties in connection with any claim arising out of any breach by you of the agreement or the foregoing representations, warranties and covenants, including, without limitation, attorneys fees and costs. You shall cooperate as fully as reasonably required in the defense of any claim. Company reserves the right, at its own expense, to assume the exclusive defense and control of any matter otherwise subject to indemnification by you and you shall not in any event settle any matter without the written consent of company.

(6) No warranty. The Reward Spot program, including all content, functions, materials and information made available to you or accessed by you through the website, is provided "as is." To the fullest extent permissible by law, company makes no representation or warranties of any kind whatsoever for the content of the Reward Spot program, the materials, information and functions made accessible through the website, or for the products and/or services awarded or redeemed through the program. Further, company disclaims any express or implied warranties, including, without limitation, non-infringement, merchantability or fitness for a particular purpose. Company assumes no responsibility, and shall not be liable for any damages by use of the Reward Spot program or the website. Company and its subsidiaries and affiliates shall not be liable for the use of the Reward Spot program, including, without limitation, the website and any errors contained therein. Company shall not be liable for any failure of the Reward Spot program, including the website, which results from acts or events beyond the company's reasonable control.

(7) Limitation of company's liability and damages. In no event shall company be liable for any loss arising from lost or stolen Reward Spot cards, nor for any direct, indirect, special, consequential or other damages arising out of the use of the Reward Spot program or the website. This includes, without limitation, lost profits, lost points, business interruption, damage to equipment, computer systems or programs, or any information system, or the loss of any information or data. The maximum liability collectively of the company shall not exceed one hundred dollars (\$100) for any damages of any nature, including gross negligence, arising in contract, tort or otherwise.

(8) Expiration of points. Points earned on a Reward Spot membership card may expire after periods of account inactivity.

(9) Entire agreement. These terms and conditions and the privacy policy constitute the entire agreement between company and you with respect to your use of the Reward Spot program. Any cause of action you may have with respect to your use of the Reward Spot program must be commenced within one (1) year after the claim or cause of action arises. If for any reason a court of competent jurisdiction finds any provision of the agreement, or portion thereof, to be unenforceable, that provision shall be enforced to the maximum extent permissible so as to effect the intent of the agreement, and the remainder of this agreement shall continue in full force and effect.
